

Boston Scientific's Galway Site in Ballybrit Commercializes Innovative Mustang™ PTA Balloon Catheter

Galway, Ireland (July 5, 2011) -- Boston Scientific's Galway site in Ballybrit is manufacturing and distributing the Company's recently launched Mustang™ Percutaneous Transluminal Angioplasty (PTA) Balloon Catheter, a highly deliverable 0.035 inch PTA catheter designed for a wide range of peripheral angioplasty procedures. The Company has launched the product in the U.S., Europe and other international markets.

The Mustang PTA Balloon Catheter represents an advance in balloon technology for peripheral angioplasty procedures. Staff at the Boston Scientific Galway site in Ballybrit have been working diligently to enable worldwide product distribution in advance of the recent market launch. It is expected to be the site's largest launch this year.

The Mustang Balloon Catheter offers excellent rated burst pressure (up to 24 atmospheres) and is the only 7 x 200 mm balloon compatible with a 5 French introducer sheath. Available in 203 sizes, it provides the broadest matrix of any available peripheral balloon.
